Beer in Stock

<u>Beer Stock</u> In view of the continued fall in Silver Exchange and the consequent increase in the price of imported stores it was decided to carry forward the Beer in Stock in the years accounts at <u>67 1/2 cents</u> per gallon.

Increase in Prices

Increase in Prices A verbal suggestion made by Mr. Isono through the Secretary that pending a contemplated meeting between the Directors of this Company and those of some rival Companies it might be well to postpone for a month or so the increase in price of Beer determined on at last meeting, was discussed. Resolved that the dates fixed should be adhered to.

Increased out-put of Beer per Brew

Increased out-put of Beer per Brew Attention having been invited to the great increase in out-turn from the brewing as compared with the previous year it was resolved to write a letter to Mr. Heckert thanking him for the success of his efforts and to present him with a cheque for \$500 as a special bonus.

Secretary's Remuneration

Secretary's Remuneration This matter having been brought forward for Consideration it was resolved that the present system of part payment by commission on foreign sales be continued but that the minimum in any month should be \$250 per month average, and further that this arrangement should be retrospective from the date on which Mr. Stewart assumed office.

Debentures

<u>Debentures</u> A suggestion offered by the Secretary to the effect that the remaining \$10,000 worth of Debentures in the hands of the Hongkong and Shanghai Bank should sold, was considered. Resolved not to do anything at present.
