Brewery Engineers The Chairman reported that notice had been given Mr. Watt of the termination of his contract and also that Mr. Watt had removed from the Company's house which he had occupied. He further reported that Mr. Chemnitz had been engaged and that the Chief Brewer reported favourably of him.
