# Minutes of Directors' Meeting held at No.7 Water Street at 4 p.m. on Wednesday 1st November 1899

<u>Present</u>: Messrs J. Dodds (Chairman), F.S. James, J.D. Hutchison, H. Baehr,W.R. Bennett and (by invitation) M. Kirkwood

#### > Articles of Association

The Minutes of the previous meeting of 27<sup>th</sup> October having been read and confirmed, Mr. Dodds stated in connection with Articles of Association that Mr. Walford had come into line with Messrs Litchfield and Lowder and that Mr. Walford would seek a preliminary interview with the British Minister. The Grand Hotel Company had registered as a branch and Mr. Lowder had undertaken to ascertain whether the local judge would register other companies in the same way – it being understood that the judge would refer the question to judicial quarters in Tokyo.

#### Finance

<u>Finance</u> The Chairman reported that the Hong Kong and Shanghai Bank had agreed to advance sufficient funds to pay the dividend of 10% for the half year, decided upon, against deposit, as collateral security, of debentures to the value of yen 100,000.-

#### Engineer

Engineer Mr. Kayser, who now attended by request, reported that Mr. Chemnitz was still sick. In answer to a question he said he considered it unnecessary to engage another engineer to take Mr. Chemnitz' place – there was no risk of anything going wrong. He was still of opinion that Mr. Chemnitz was not quite suitable for the new brewery; whereupon the

question of the best means of severing connection with Cheminitz after the appointment of another man, was spoken of.
