Export Trade in China

The Managing Director stated that the Meeting had been called in an informal manner, to enable him to ascertain the views of the Director as to the advisability of Sending Someone across to China to work up the Export Trade. This was discussed as for private Minute book.

Yokohama Water Works

The managing Director stated that he arranged with the Yokohama Water Works, for the laying of a 4 inch pipe in to the Brewery Compound, the erection of a Private Hydrant, and one inch connecting pipes with meters, for a constant supply of water to the Brewery.

Proposals from Meidiya for Export of Kirin Beer

He further stated that Meidiya had made proposals for starting the Export of Kirin Beer, but that he had written to Mr.Yonei, telling him, that unless Meidiya would agree to pay current export prices, less the usual discount allowed to Exporters, with cash on day of shipment, no arrangement could be come to. As any further commission would place the Agents of the Brewery in a worse position than Meidiya. It was decided to give no further inducement to Midiya, but to keep the export trade in the hands of the Brewery as much as possible.

Brewer's Association

The Managing Director stated that he had been in correspondence with the Brewers Association in reference to suggesting to the government a method for the gauging of Beer to be taxed- and had advocated a Meeting of the Association on the subject, but it was thought by the Yebisu Brewery, that the government had come to some understanding, & a Meeting would be useless.

Spurious Kirin Labels

He reported that Meidiya had found out that Kirin labels were being made & sold in Tokyo, and that he was going to consult with Mr. Ideura as to the advisability of taking Legal proceedings.
